The members of Pequea Township and Recreation Board met on Wednesday, February 8, 2012 at 7:00 pm in the conference room of the Pequea Township Municipal Building, 1028 Millwood Road, Willow Street, PA 17584.

Meeting called to order by Lew Witmer at 7:00 pm with the Pledge of Allegiance.

Approval of January 11, 2012 Minutes: Steve Gogoj made a motion to accept the minutes from the January 11, 2012 meeting, seconded by Janet Hess. All voted in favor, none opposed.

- 4) Mower for park – Steve Gogoj made a motion to purchase the mower and submit to the Township Supervisors for approval. Motion was seconded by Joan Gogoj. All in favor and none opposed.
- 5) Piccadilly Circus - Lew Witmer submitted information regarding Piccadilly Circus which will be submitted to the Township Supervisors for approval before any action is taken.
