On December 15, 2018, the Township will celebrate 24 years of ownership of the 84.6 acres known as the southern portion of Silver Mine Park.

The use of the Property, as defined in the Agreement dated, December 15, 1994, shall be restricted to open space/parkland/recreational purposes. The Property shall be utilized perpetually for park and recreational purposes. If, when and as it is deemed inappropriate to utilize said real estate for active park and recreational purposes, it is agreed, understood and hereby declared as a declaration, restriction and covenant running with the land that the utilization shall be for passive recreation or open space. The term of this restriction shall be perpetual and it shall be a covenant running with the land.
