## **CALL TO ORDER**

To the Board, I simply ask that we work diligently and if a Supervisor feels something should be changed, please give a new number and then we'll need 2 others for a total of 3 Board members to agree to the change. If no one desires a change, we will move on to the next unresolved item.

- 1. Second Review of 2020 Proposed Budget
  - a. Highway Aid Fund
  - b. State Highway Fund (Liquid Fuels)
  - c. Recreation Fund
  - d. General Fund

In this workshop, the line items of the various "Funds" above, had unresolved monetary figures. We will go through those line items to come up with agreed upon amount.

There is no need for the 3<sup>rd</sup> budget workshop.
