#### 13. Set amount of Treasurer Bond

Chair Purdum moved to set the amount of the Treasurer Bond at \$2 Million - \$1 Million each for Treasurer and Assistant Treasurer. It was seconded by Vice-Chair Cazillo. The motion passed with all voting in favor; none opposed.

# 14. <u>Resolution – Appoint Chief Administrative Officer of the Non-Uniformed Employees' Pension</u> Plan

Chair Purdum moved to adopt Resolution 532-2020 appointing Nancy M. Keebler, Treasurer as Chief Administrative Officer of the Pequea Township Non-Uniformed Employees' Pension Plan for the purpose of carrying information to the Department of the Auditor General and to administer funds with the Principal Financial Group It was seconded by Vice-Chair Cazillo. The motion passed with all voting in favor; none opposed.

# 15. Resolution – Appoint Chief Administrative Officer of the Uniformed Employees' Pension Plan

Chair Purdum moved to adopt Resolution 533-2020 appointing Nancy M. Keebler, Treasurer as Chief Administrative Officer of the Pequea Township Uniformed Employees' Pension Plan for the purpose of carrying information to the Department of the Auditor General and to administer funds with the Principal Financial Group. It was seconded by Vice-Chair Cazillo. The motion passed with all voting in favor; none opposed.

#### 16. Resolution - Appoint Depositories for 2020 - PNC Bank and PLIGIT Accounts

Chair Purdum moved to adopt Resolution 535-2020 appointing PNC Bank and Pennsylvania Local Government Investment Trust (PLGIT) as depositories for the year 2020. It was seconded by Supervisor Edwards. The motion passed with all voting in favor; none opposed.

#### 17. Resolution – Appoint Treasurer as Signatory for SRPC Checking Account

Chair Purdum moved to adopt Resolution 534-2020 appointing Nancy M. Keebler as a Pequea Township signatory for the Southern Regional Police Commission Checking Account. It was seconded by Supervisor Lucas. The motion passed with all voting in favor; none opposed.

# 18. Resolution – Authorize revision of Fee Schedule for fees charged in connection with the Township Zoning Ordinance Applications and other fees associated with the administration of the Township.

Chair Purdum moved to adopt Resolution 536-2020 authorizing the change of fees in the Pequea Township 2020 "Fee Schedule" associated with Township Zoning Ordinance Applications and other fees associated with the administration of the Township, as recommended by the Township Zoning Officer. It was seconded by Vice-Chair Cazillo. The motion passed with all voting in favor; none opposed.

#### 19. Appoint Benecon Benefits Administrator

Chair Purdum moved to appoint Nancy Keebler as the Benecon Benefits Administrator. The motion was seconded by Vice-Chair Cazillo. The motion passed with all voting in favor; none opposed.

#### 20. Appoint Permanent Part Time Assistant Treasurer

Chair Purdum moved to appoint Kim Ulaky as the permanent part time Assistant Treasurer. The motion was seconded by Supervisor Edwards. The motion passed with all voting in favor none opposed.

# 21. Appoint Permanent Part Time Assistant Secretary

Chair Purdum moved to appoint Nancy Keebler as the permanent part time Assistant Secretary. The motion was seconded by Vice-Chair Cazillo. The motion passed with all voting in favor; none opposed.

# 22. Appoint Roadmaster

Supervisor Edwards moved to appoint Jeff Fry as the Roadmaster as a rate of \$28.00/hour effective 01/06/2020. The motion was seconded by Supervisor Hlavacek. The motion passed with all voting in favor; none opposed.

Supervisor Edwards also moved to amend Item 11, changing "Road Foreman/Roadmaster" to simply "Roadmaster". Chair Purdum seconded the motion. The motion passed with all voting in favor; none opposed.

#### 23. Set Township hours for 2020

Chair Purdum moved to set the Township hours for 2020 as 9:00am – 4:30pm, Monday through Thursday; closed Friday. The motion was seconded by Supervisor Edwards. The motion passed with all voting in favor; none opposed.

#### 24. Set Mileage Reimbursement Rate for 2020

Chair Purdum moved to authorize mileage reimbursement for employees, supervisors, and volunteers who use their personal vehicles for approved township business at the rate of 57.5 cents per mile set by the Internal Revenue Service for 2020. The motion was seconded by Vice-Chair Cazillo. The motion passed with all voting in favor; none opposed.

#### **PLANNING & ZONING**

#### 25. Appoint Zoning Officer

Chair Purdum moved to appoint Solanco Engineering Associates, LLC as Zoning Officer for Pequea Township and set pay according to the 2020 Rate Schedule. The motion as seconded by Vice-Chair Cazillo. The motion passed with all voting in favor; none opposed.

#### 26. Appoint Building Code Official and Code Enforcement Officer

Chair Purdum moved to appoint Mark Deimler as Building Code Official and Code Enforcement Officer for Pequea Township and set pay according to the 2020 Rate Schedule. The motion was seconded by Vice-Chair Cazillo. The motion passed with all voting in favor; none opposed.

# 27. Resolution – Appoint Zoning Hearing Board member

Supervisor Edwards moved to adopt Resolution 537-2020 appointing Jeffrey G. Kreider\_ to the Pequea Township Zoning Hearing Board for a five-year term ending January 2024. It was seconded by Vice-Chair Cazillo. The motion passed with all voting in favor; none opposed.

#### 28. Set Zoning Hearing Board members' rate of pay

Chair Purdum moved to set the rate of pay for Zoning Hearing Board members at \$40.00 per meeting attended. It was seconded by Supervisor Edwards. The motion passed with all voting in favor; none opposed.

#### 29. Set Zoning Hearing Board Solicitor's rate of pay limit

Chair Purdum moved to set the rate of pay for the Zoning Hearing Board Solicitor not to exceed \$155.00 dollars per hour. It was seconded by Supervisor Edwards. The motion passed with all voting in favor; none opposed.

## 30. Appoint Planning Commission member

Chair Purdum moved to appoint Neil Freidly to the Pequea Township Planning Commission for a four-year term ending January 2023. It was seconded by Vice-Chair Cazillo. The motion passed with all voting in favor; none opposed.

#### 31. Appoint Municipal Representative to Route 272 Study Advisory Committee

Chair Purdum moved to appoint Supervisor Hlavacek to serve as a Municipal Representative to the Route 272 Study Advisory Committee for 2020. It was seconded by Supervisor Edwards. Supervisor Hlavacek noted that this study committee is winding down and the study is mostly complete. The motion passed with all voting in favor; none opposed.

# 32. Appoint UCC Inspection Agency (1 of 2)

Chair Purdum moved to appoint Commonwealth Code Inspection Service as a Uniform Construction Code (UCC) Inspection Agency for Pequea Township for the year 2020. It was seconded by Supervisor Edwards. The motion passed with all voting in favor; none opposed.
