This will confirm that at a hearing on June 2, 2020, the Pequea Township Zoning Hearing Board granted your request for a Special Exception pursuant to Section 703.2 of the Pequea Township Zoning Ordinance to allow the addition of two dwelling units to an existing dwelling on 3.5 acres located in the R-2 Zoning District, subject to the following conditions:

- (i) Applicant shall connect the property to the public water supply that is available and;
- (ii) Development shall be in accordance with the plans and documents, including the application and testimony in support thereof, presented to the Zoning Hearing Board.
