1. Consider approving awarded road bid projects for 2021

A. Supervisor Edwards moved to award Martin Paving Inc., the seal-coat bids for Linestown Road from 272S to Radcliff Road, Herrville Road from 272 N to the Penn-Dot shed and Brooks Ave. from 272 N to Herrville Road in the amount of \$44,694.80 and to be paid from the State Highway Fund. Supervisor Lucas seconded the motion. All voted in favor; none opposed.

- B. Supervisor Edwards moved to award Pennsy Supply Inc. the paving bid for Penn Grant Road from 272 N to 272 S and 272 S to Millwood Road, Pleasant View Drive from Penn Grant Road to the Township line and Casey Drive from Nolt Ave. to the Township line in the amount of \$180.771.68 and to be paid from the State Highway Fund. Supervisor Lucas seconded the motion. Supervisors Lucas, Lehman, Cazillo and Edwards voted in favor; Supervisor Hlavacek opposed.
- C. Supervisor Edwards moved to award Long's Paving the paving bid for the Pequea Township Municipal Building's parking lot in the amount of \$18,726. 75 and to be paid from the General Fund. Supervisor Hlavacek seconded the motion; none opposed.

Supervisor Lucas moved the Pequea Township BOS approve Barbara Long's request to install, at no cost to the Township, a memorial park bench at Silver Mine Park. Supervisor Edwards seconded the motion. All voted in favor; none opposed.
