Chairman Lehman announced that the repair of the park truck is an item of new business and that he would like to add an addendum item related to adjustment of part-time police wages. Lehman added that a representative to the SLSA Board would not be necessary tonight as Supervisor Lucas holds that position until May of 2024.

29. Set Zoning Hearing Board Members' Rate of Pay

Supervisor Lucas moved to set the rate of pay for the Zoning Hearing Board members at \$40.00 per meeting . Vice Chairman Haas seconded the motion. All voted in favor; none opposed.

30. Set Zoning Hearing Board Solicitor's Rate of Pay Limit

Chairman Lehman moved to set the Zoning Hearing Board solicitor rate of pay limit at \$155.00 per hour. Vice-Chairman Haas seconded the motion. All voted in favor; none opposed.

31. Appoint Planning Commission Member for a 4 year term to end 1/5/2026

Chairman Lehman moved to appoint Robert Heckrote to the Planning Commission, term ending 1/5/2026. Supervisor Lucas seconded the motion. All voted in favor; none opposed

 - Vice-Chairman Haas gave a summary of the 1986 park truck's repair needs, rationale for repairing and the estimated costs. Haas then moved that we get the 1986 park truck brake work, lift cylinder, exhaust work and inspection done. Chairman Lehman seconded the motion. All voted in favor; none opposed
- 2. Chairman Lehman moved that we increase the part-time police workers' wages by 2% for the year 2022. Supervisor Lucas seconded the motion. All voted in favor; none opposed.

- 1. Supervisor Hlavacek announced that January was Radon Awareness Month and urged residents to purchase a detection unit for this serious threat.
- 2. Supervisor Lucas announced that the Pequea Township Police Department is participating in a Lancaster General Blood drive called Bleed Blue, a contest awarding a plaque to the township with the most donors. Everybody wins!
